Context

The insurance sector is highly regulated, with the aim of protecting policy holders and guaranteeing the protection of their personal data.

Groupe Henner obtained its ISO 27001 certification in 2016 for its French sites and its Lisbon site.

This certification demonstrates the Group's long-term commitment to complying with regulatory constraints on personal data protection and information system security.

Challenge

This certification is steered by the SSI team, comprising 4 people: 1 CISO and 3 IS security engineers, including one responsible for ISO 27001 audits.

Henner Group wanted to equip itself with a tool enabling it to:

- maintain its existing certification;
- manage the compliance of other sites with a view to extending certification to other areas.






Solution

Tenacy is the solution chosen by the SSI team to meet this need. The ISO 27001 standard is one of the cyber standards available in Tenacy's catalog, and can be easily deployed on a perimeter to be secured. For each measure in the standard, the following are pre-configured: security measures to be applied, recurring tasks and monitoring indicators.

The solution enables recurring actions or tasks to be assigned to the various contributors, who are notified and can enter the indicators directly into the solution. Tenacy's organization modeling functionality enables Groupe Henner to apply and monitor each element of the ISO 27001 standard across its various security perimeters.

Results

All data is centralized, enabling Henner Group to have a 360° vision and share it with all stakeholders, thanks to dashboards built in just a few clicks and offering a granularity that allows it to adapt to its interlocutor.

Around ten employees, in addition to the SSI team, now use Tenacy to track the tasks assigned to them and record their results, simplifying the monitoring of the SSI team.

The audit manager recognizes a significant time saving in the production of dashboards and appreciates the centralization of data.

Now what?

Although Henner Group initially chose Tenacy to manage its ISO 27001 compliance, deploying and getting to grips with the tool through this use case enabled the SSI team to explore and establish a roadmap for future use, with the aim of eliminating all Excel files from their daily routine. This will involve logging security incidents and integrating project security questionnaires.
